7-2-09 (11:20a) Kendall County Solid Waste Coordinator, Marlin Hartman paid a visit to and spoke with complainant, who expressed concern over litter observed in a farm field bordering his residence (to the south). It was determined that the field was owned by and part of Hamman Farms, an on-farm yard waste land application operation. During his visit Mr. Hartman observed litter and debris on the surface of the farm field in the form of residential waste such as an aluminum beverage container and a spent bag of yard mulch. Mr. Hartman photographed his observations (attached to this complaint), thanked the complainant for his time and information, and moved on to the Hamman Farms entrance where he met with and spoke to Hamman Farms site manager, Larry Cooper.

During his visit with Mr. Cooper, Mr. Hartman observed a lull in the grinding and spreading of yardwaste materials as there was no material to process and Hamman Farms was awaiting delivery of a load of materials. Concurrently, Mr. Hartman observed several Hamman Farms laborers "walking the field", manually picking up litter and debris. Mr. Hartman noted that this litter pick-up procedure, while effective to a point, could be improved upon. Mr. Hartman stressed to Mr. Cooper the need to do a better job of litter control, specifically at the point of material drop-off/receipt. Mr. Cooper stated the litter can be hard to find/separate out during this phase of the process. Mr. Hartman suggested that Mr. Cooper, at minimum, spread the dropped off piles into a thin layer (before grinding and applying) in an effort to locate and remove more if not all litter contained within yard waste materials deliveries.

Before leaving the site, Mr. Hartman took note of wind direction and speed, W/NW at 10 to 12 mph; and the ambient temperature, 75F. Finally, Mr. Hartman took note of the depth of material spread on the surface of the farm field at approximately 3 inches thick.

This complaint and related observations will be kept file with the Health Department, a copy furnished to the Illinois Environmental Protection Agency. MH
