**Narrative

The following narrative contains information pertaining to both this compliant (#09-078) and complaint #09-082 (Hamman Farms).

6/11/09 - Eric Campbell visited the above referenced properties (Hamman Farms' Sleepy Hollow Road site; and 9225 Lisbon Road, which is located in the middle of this Hamman Farms yardwaste land application site) to observe the alleged conditions of loose and plowed-up litter and debris (e.g., paper, plastic bags, etc.) present across said properties. During this visit, Mr. Campbell did in fact observed

accumulations of both loose and "plowed-up" litter and debris. This litter and debris was observed in the form of sheet plastic, plastic bags, scraps of paper, and other items possible related to domestic/household trash (e.g., one pair of womens pantyhose). Mr. Campbell took a series of photographs during this visit, and was instructed to forward them along with the information contained within this report to the Illinois Environmental Protection Agency (per the advice of the Kenball County State's Attorney) . It is presumed that this information will then be forwarded by the IEPA to the Attorney General's Office, who is currently enagaged in the implementation of a Notice of Violation against Hamman Farms for similar if not the same concerns.
